Intro to tricks - Awakening The Learner - Build the bond between you and your dog

This class is for those who have not taken a tricks class or want to build on the beginning skills of training tricks. We will cover tricks needed to attain the AKC/DMWYD Novice tricks Titles

Advanced Tricks - The Journey Continues

This class is for those who have previously taken a tricks class. More advanced skills/tricks will be taught in this class.

Canine Explorer - Building confidence and 'Exposure to new' - limit 4 teams per session!

This class will introduce new items each week for the dogs to explore, interact with, sounds, textures, equipment, etc. Especially helpful for puppies, young dogs and dogs that are cautious. Emotionally safe, kind, no pressure exposure and learning for you and your dog.

Classes/groups will run 45-60 minutes each, unless otherwise noted.

There are no refunds after the start of the first class/4-week session.

Payment and paperwork must be received before your spot is confirmed in the class.

CLASS SUPPLIES AND REQUIREMENTS

(Does not need to be mailed in. This is for your reference)

1. DRESS

- a. Rubber soled comfortable shoes.
- b. Comfortable clothing.
- c. Hair tied back if long.
- d. No flowing sleeves, pant legs, or jewelry.

2. EQUIPMENT

- a. Puppy Class
 - i. 6-foot pliable leash and buckle collar
 - ii. Small, soft treats
 - iii. Small rug or mat
 - iv. Small bowl for water
- b. Obedience Classes
 - i. 6-foot lead and buckle collar
 - ii. Soft treats
 - iii. Training pouch (suggested item, not required)
 - iv. Rug, mat or crate
 - v. Bowl for water

3. CLEAN UP

- a. You are responsible for clean-up of your dog's accidents inside and outside the facility.
- b. Bring plastic bags for clean-up.

***Spray and paper towels for inside clean-up will be provided. ***

4. HEALTH

- a. All vaccinations must be current, puppies based on age, others within the year, and rabies within two years.
- b. Health certificate must be completed by your vet and returned by first session.
- c. Sick dogs should be seen by a vet to verify they are not contagious to the rest of the class.
- d. Bitches in heat will be allowed only at the discretion of the instructor.

5. VICIOUS AND WILD ANIMAL CROSSES

- a. You must notify the instructor if your dog bites.
- b. No wild animal crosses will be allowed.

***You are responsible if your dog bites someone or another dog. If you can't control your dog, you may be asked to leave the class and your money will not be refunded. ***

Dog Training/Walking Liability Waiver and Release of Rights

The undersigned participant hereby acknowledges that he/she is voluntarily participating in dog training/walking with Dogzausted LLC who will exercise all necessary and proper care and precautions to keep participants and dogs safe during training/walking and to prevent injury to any person, property, other dog or person. Undersigned waives, releases, discharges, and covenants not to sue Dogzausted LLC and/or Kathy Sjomeling, from any and all liability to the undersigned for any loss, harm, damage, claim, injury or accident to the person or property of the undersigned, whether caused by an ordinary negligent act or omission of the releases while the undersigned or his/her dog is engaged in or participating in dog training/walking or using any trainer or business facilities in connection therewith.

The undersigned expressly agrees that the foregoing release and waiver, and assumption of risk are intended to be as expansive, broad and inclusive as permitted by South Dakota Codified Law.

Nothing herein is intended to release from any harm, injury, claim or damage caused by intentional torts or reckless misconduct. Further, participant agrees to hold harmless Dogzausted LLC/Kathy Sjomeling from any and all claims of injury, loss, cost, expenses, or damage caused by the actions of the participant's dog during the course of training walking, or under the care, custody, control of Dogzausted LLC/Kathy Sjomeling.
